# 1- CALL TO ORDER/QUORUM

#### 3- OLD BUSINESS

### A- Lawsuit

Discussion was held regarding the proposal to ask our attorney, Robert Taylor, to communicate with Harbor Hills attorney, Philip Smith, regarding the Grove Board's offer for settlement of the lawsuit in the May 10, 2011 letter. Ms. Korndoerfer arrived. After the discussion was held, Ms. Walker moved, Ms. Korndoerfer seconded, the Board request Mr. Taylor send a letter to Mr. Smith informing him that if we do not hear from him after the time stated in the letter, the settlement proposal sent in our May 10, 2011 letter will be withdrawn. The motion passed unanimously. **MOTION #3** 

### 4- NEW BUSINESS

#### A- Touch Keys

Mr. Frame stated he has become aware of the fact that several residents have multiple touch keys. Some have been given by residents to out of state relatives. Discussion followed including the potential security problems that could occur with excessive numbers of entry keys that have been distributed. By consensus, the Board authorized Mr. Frame to draw up a rule to be presented to the Board for approval, regarding the number of touch keys any resident may have.
