Discussion followed. Mr. Crima will investigate the cost for vandalism insurance. Ms. Strack moved, Mr. Crima seconded, we approve the increase in the insurance premium of \$276.00 for the additional coverage and that we will check on the cost for additional insurance for vandalism. - 1- Mr. Frame noted there had been damage to our new speed signs. Discussion followed.
- 2- Ms Strack noted tools were stolen from Frank Quarle's truck that was parked in her driveway.
- 3- Mr. Frame distributed a cost sheet for the well project. It will be attached to the minutes.
