## **5-FUTURE PROJECTS**

## A-SECURITY CAMERAS/DVR

Discussion was held regarding upgrading the DVRs and the cameras. Mr. Gussler has sources for both areas. He will get the information to Mr. Frame and Mr. Holden. They will get the additional information that is needed to make a decision on what to use.

#### **B-RFID SYSTEM**

Mr. Frame reviewed the proposed RFID (transponder) system for the West Gate. Discussion followed. Mr. Frame read our attorney's letter stating no contact with HHHOA's board should

occur as long as the lawsuit is ongoing. After the Appellate court decides our case, we hope to have Mr. Holden and Mr. Gussler contact a resident member of the HHHOA board to discuss possibly having transponders connect all HH gates and the West Gate for universal residents' access. Neither the Grove HOA's nor the HHHOA's presidents will be involved in the talks. If the new system is installed, the Grove's residents will be eligible to receive up to 2 transponders, at no cost. Details will be formulated at the appropriate time.

#### **6-LEGAL UPDATE**

Mr. Frame noted the Appellate court has set April 21, 2016 at 9:00AM in Orlando for our oral argument hearing. Discussion followed.

## 7-MISCELLANEOUS

A-Mr. Frame got prices for children playing street signs. Discussion followed. Mr. Gussler will follow up on this.

B-Mr. Gussler asked about the mosquito control question that was raised at the Annual meeting. Discussion followed. It will be looked into.

C- Discussion was held about the possibility of the Grove having a Facebook account. The pros and cons were discussed as well as the fact that there are many different types of accounts. Mr. Waldrop will talk with Dana Delzio regarding it. Any such venture would have to have Board approval first.

D-Mr. Holden remarked on the letters sent by Ms. Christopher to residents that have violated rules. Street parking, more than 2 cars stored in driveways and outside play equipment were mentioned. Discussion followed. Ms. Christopher will continue to follow up on complaints.
