### 1- CALL TO ORDER/QUORUM

# 2- APPROVE 8/29/2017 MEETING MINUTES

# **3-** FINANCIAL UPDATE

Mr. Frame noted the quarterly coupons were late in being sent out. This may affect the timing of our cash flow. He also stated the monies have not been moved yet from TD to Union bank. He reviewed the effects of Hurricane Irma on our budget. We had to purchase a new pump for the retention pond by the cart path by #9 hole. It had been full of water before the hurricane and the new pump emptied most of the water prior to Irma, but the street at the bottom of the cart path flooded from all of the rain we received. He reviewed the costs of the equipment he had to pay for the pump and hoses. It was \$718.08. Delmer Brooks worked 3 days @ \$450 per day on cutting up the downed trees that blocked the path. Clean Aire landscaping cleaned the sides of the maintenance road for \$400. Mr. Frame assisted Mr. Brooks in cutting and removing the debris and the trees. We had a large number of residents who also helped with the cleanup. Discussion followed.

# 4- 2018 BUDGET

Mr. Frame distributed the draft budget. Mr. Gussler arrived at 7:17PM. Mr. Frame reviewed each line item. Discussion ensued. He noted that we had previously approved putting any surplus, that is over \$3,000, from each year's budget into reserves. The Board reaffirmed that plan. He stated the cost for the pump and hoses will be paid for from our reserve account. Discussion included the information that Harbor Hills HOA is going to assess each of their residents between \$100 and \$ 200 for cleanup. Ms. Grillo moved, Mr. Gussler seconded, the 2018 budget be approved. The motion passed unanimously. **MOTION # 2**
